Membership application blanks are in the back of the quarterly. 1967 has been a good year for our Society; and many of our objectives have been accomplished or carried on toward accomplishment. I wish to thank the officers, directors, committee chairmen and members who did the work. Mr. BREEDING, our 1st Vice-President, took over in my absence, as well as serving as chairman of the Membership Committee. Mrs. WINSBOROUGH, our 2nd Vice-President, provided us with excellent programs throughout the year. Our Recording Secretary, Mrs. RUGELEY, and our Corresponding Secretary, Mrs. DUNAWAY, did fine jobs, as did our Treasurer, Mrs. BARCUS.

Outstanding work was accomplished by the Acquisitions Committee under Mrs. JOY, by the Ancestor Records Committee under Mrs. LONG, by the Bible Records Committee under Mrs. BICKLER, by the Cemetery Records Committee under Mrs. SPEARS, and by the Church Records Committee under Mrs. MORRIS. <u>Gleanings from the Exchange Librarian</u> - When Miss Sumner was asked if she had anything to share with us in the Quarterly, she came up with a bit of helpful information which she had gathered on the spot, not out of the Exchanges. She says that the Department Of Archives and History of North Carolina, P. O. Box 1881, Raleigh, North Carolina has all of the county records of North Carolina on microfilm and that they can be purchased for \$8.00 a reel. While they do not have a catalogue of their holdings, if you write and tell them what you want, they will tell you how much it is.

Miss Sumner also saw an abstract of genealogical information from the <u>Hornet</u> which was published in Hertford county, North Carolina before 1830. There were only a few copies in existance and Mrs. Taney Brazeal, Route 2, Box 5, Fairhope, Ala. 36532 has done this abstracting and is selling the material, which amounts to ten or twelve pages for \$1.25. Hertford county is one of the burned counties making material scarce.

# BAPTISMS OF THE FIRST SOUTHERN PRESBYTERIAN CHURCH

# Austin, Texas Minutes Of Session (1875-1893)

These records appear with the permission of the Minister, Rev. Frank B. Walker, Jr., and the Sessions of the First Southern Presbyterian Church of Austin. We were indeed fortunate to be allowed the privilege of using these fragile old records. Mrs. Jeff M. Irwin, Jr., Church Secretary, was most helpful in explaining where the papers were and in making suggestions. The Session book is old, the handwriting faded and done in several different hands. Care has been taken to compare the several entries for a single name in an attempt to get the correct spelling. The original records were used as nearly as possible as they appeared, considering that the material was rearranged. The list of Baptisms was begun in September 1877. Those which preceed that date were abstracted from the Minutes and have been added to the list. Abstracted and prepared by Evelyn McDaniel Morris-Chairman, Church Records Committee.

### REPORT OF CHURCH RECORDS COMMITTEE

Church records are not public records. It is necessary first to find where the records are deposited, and then it is necessary to get permission, not only from the Minister or the Priest in charge, but also from the Board of Governors, both to study the records and to publish them. This is as it should be. The records must be protected and must not fall into careless hands.

We wish to acknowledge our indebtness to Mrs. Stuart Purcell for preparing the way for us to be allowed to use the records of the First Southern Presbyterian Church of Austin, Texas.

Mrs. Raymond R. Russell, a member of this committee, has been searching for available records. She had hoped to get the use of the Hallettsville Catholic Church's records. After making a trip down there, she learned that the records had been deposited in the Catholic Archives in San Antonio. She also made a search for records of Hainey's Chapel. She learned that copies of the extant records have been placed in the Texas State Archives. He third investigation concerned old Bethany Chapel, a Baptist Church. She was not able to find any old records. They were supposed to have been lost. Our thanks to Mrs. Russell for her work.

Other Churches whose records might be of interestare the First Baptist Church of Austin and the old Walnut Creek Baptist Church.

Again, we wish to express our gratitude for the use of the records from the Minutes Of Session (1875-1893) which the First Southern Presbyterian Church so graciously allowed us. # FIRST SOUTHERN PRESBYTERIAN CHURCH, AUSTIN, TEXAS MINUTES OF THE SESSION (1875-1893)

This is the oldest Minute Book extant for this Church. It contains two rolls as well as the minutes. Prior to November 1876 there were no dates of entry shown on the roll, nor were there notations as to where the letters were from. Therefore, it is to the Minutes Of The Session that we have to go to find a record of previous membership. Even after the Clerk began to enter more data on the roll there was still more information in the minutes than was shown on the roll. The following abstracts from 1875-1878 were prepared by Evelyn McDaniel Morris.

#### Page 1.

Feb. 6, 1875 Austin, Texas. Rev'd. John S. GRASTY, D. D. acted as Moderator. Mr. Mortimer SOMEROW and Mrs. Anna SOMEROW, husband and wife, presented themselves, asking admission into the Church . . . after examination . . . they were cordially received into membership . . . J. H. HUTCHINS Clk pro tem.

Feb. 18, 1875 - Revd. Dr. GRASTY Elders present, A. H. COOK, N. A. MILTON, and J. H. HUTCHINS Dr. Nace BEAUMONT and his wife Mrs. Mary E. BEAUMONT were admitted into this Church by letter from the Church at Corsicana, Texas, also Mr. John BLACK was received by letter from the church at Charlottesville, Virginia. (Clerk is same until further notice)

### Page 2.

March 4, 1875 - Present Moderator Revd. Dr. GRASTY, and Ruling Elders A. H. COOK, N. A. MILTON and J. H. HUTCHINS . . . Eva GLENN, a young colored woman presented herself, asking to be received into membership . . . after examination as to her religious experience, and the motives inducing her to seek a union with God's people, she was admitted . . .

March 11, 1875. . . The following persons, Miss Minnie C. DEWEY, Miss Susie B. HUTCHINS, Mr. Edwd. M. STRINGER and Mr. M. I. McSWAIN presented themselves asking admission into this Church - They having severally given the session . . . evidence of faith in Christ . . . received.

Page 3. March 18, 1875 - Mr. Emory E. MILLETT asked admission into the Church. . was received . . .

April 1, 1875. Elders present. . Dr. P. P. CLUFF, N. A. MILTON and J. H. HUTCHINS. Miss Lizzie P. ERWIN presented herself. . . after giving satisfactory evidence that she had accepted Christ as her Savior she was admitted . . . Page 5.

May 6, 1875 - . . Present the pastor . . & Elders J. H. HUTCHINS & G. ROGAN - after prayer Mr. Samuel M. HOPPING asked to be admitted to . . . Church , & on examination . . . was received.

July 1, 1875 - . . . Pastor & Elders COOK, ROGAN, CLUFF & HUTCHINS. On letter from 1st Congregation (sic) Church, New Orleans, Miss Fannie STRINGER was received . . . Elder ROGAN tending his resignation of the position of Clerk of Session, the same was accepted, & on motion, Elder J. H. HUTCHINS was appointed Clerk . . J. H. HUTCHINS Clk.

Page 6. July 11, 1875 - . . This day, Judge M. KRISLE by letter from the Goliad Church Texas, & Judge John N. LYLE, by letter from the Christianburg Church Virginia were received into the membership of this Church. . .

July 18, 1875 - . . This day Mr. John B. SHERRARD a Ruling Elder of the Presbyterian Church of Sherman Texas, and Mrs. Emma V. SHERRARD were by letter from said Church received into . . . this Church.

Also, this day before dismissal of the Congregation Dr. Robert GRANT, formerly a Ruling Elder of the Wytheville Presbyterian Church, Virginia, and Judge J. N. LYLE of Christianburg, Virginia were duly elected Ruling Elders in this Church, and Dr. J. W. BURT, formerly a Deacon in the ----- Church Arkansas, was elected to the same office in this Church -The usual installation of Judge LYLE, as Ruling Elder, was set for next Sab.

John Hemphill, Esq. of this city has been elected Judge of the fourth Judicial District, in place of James W. Robinson, resigned. He is a sound lawyer and an upright man, and we congratulate the bench and the county upon his election.

. . Messrs. Burgess and Starke from Mississippi have arrived in this city. They have forty horses and several fine post coaches, and design shortly to establish a line of stages between this city and Houston . . .

We hope to see a better arrangement made for the transportation of the mails between Galveston and this city. We have not received a paper or letter from Houston or Galveston for the last three weeks . . .

The following gentlemen have been elected Mayor and Aldermen of the City of Austin.

An old gentleman by the name of Kaufman who has been engaged in hunting about this city for a few weeks past has been murdered 6 or 7 miles from Bartons, on the West side of the Colorado river; it is supposed by Tonkahua(sic) Indians. The Indians had been encamped for some time near this city and had been treated with uniform friendship by our people. On breaking up their camp, the temptation to steal a few horses was too great to be overlooked, and they were not willing to depart without leaving the citizens a proof of their dexterity in this business. They accordingly selected one of the best horses in the neighborhood and left. On their departure they fell in with Kaufman and murdered him to prevent exposure.

They are now encamped on the West side of the Colorado river, about 20 miles below this city. The citizens of that neighborhood may expect a similar proof of their friendship and devotion to the whites . . .

#### OBITUARY

Died, on Friday the 11th inst., near this city, Mr. Wm. Barton, aged 58 years.

Mr. Barton was a native of South Carolina and moved to the state of Alabama during the wars with the Indians in 1816 and 1817. From that state he came to Texas. His whole life has been spent upon the frontier, and he has been aptly styled the Daniel Boone of Texas. He has seen many hairbreadth escapes and a narrative of his life would form a very interesting biography. He removed to the place where he died about three years ago. He was then twelve miles above the highest settlers on the east of the Colorado, and on the west there was not another person for more than forty miles. The Indians frequently surrounded his house and have taken a few shots at him- he has always contended that he should never be murdered by an Indian.

In his manners he was frank and confiding, and died not only lamented by his old companions upon the frontier, but by all who have become acquainted with him, since the rapid settlement and improvement of the country around him. He was emphatically an honest and an upright man.
