Saturday, Sept. 26, 1840 p. 3, col. 2

Died - In this city, on the 10th inst., of congestive fever, Mrs. Margaret Laughlin, consort of David Laughlin, Esq.

Her loss to her family is irreparable, and society is deprived of an unpretending but kind hearted and useful member. So far as her humble ability would permit, she needed no other prompter than her heart, to deeds of charity and benevolence; and the blessing of many an unfortunate stranger, who has experienced her kindness and attention in sickness and affliction, follows her to her grave.

Saturday, Oct. 3, 1840 p. 3., col. 2

Married - In this city on Thursday evening last, by Hon. J. W. Smith, Musgrove Evans, esq. to Mrs. Richardson.

For Sale - A small tract of land, lying on Cedar Creek, a few miles above Esquire Patton's. The tract contains 115 acres, and is admirably adapted for a stock farm. About one half the land is creek bottom, nearly the whole timbered. There is a small cabin and some cedar rails on the place. Any person wishing as small a tract, would do well to examine this. Saturday, Oct. 10, 1840 p. 2, col. 2

Capt. Wiehl, in company with Mr. Lindsey, surveyor, started on Thursday last, from this city, to lay off a road to the San Marcos spring. At that place there is to be a regular post kept up; it will be for the present under the command of Capt. Wiehl. It is about the halfway ground between this city and San Antonio.

Capt. Skerrett will leave on Monday, with one company of the regular infantry, to join Col. Cooke, who is running the Military Road to Red River.

Sixty dollars reward - For John O'Maley and Edward Fitzgerald, deserters from Austin Arsenal, Oct. 5, 1840.

Description - John J. O'Maley, age 24, height 5 feet 8 inches, complexion fair, eyes blue, hair red; he carried with him a short (sic) gun, wore a blue cap and grey fatigue jacket, born in Ireland.

Edward Fitzgerald, height 5 feet 7 inches, age 21, complexion fair, eyes dark, hair dark, born in N. York, of Irish descent, supposed to have taken with him a Colt's patent rifle.

One of the most interesting and well arranged rural parties we have ever attended, was given by Mr. and Mrs. Combs, on last

Wednesday evening. The beautiful grove in front of their house was completely illuminated, and everything was so brilliant that it had very much the appearance of having been touched by a fairy's wand.

The refreshments provided for the occasion, were the choicest and most delicate kind; and nothing was wanting to make the festivities of the evening complete.

We understand Mr. and Mrs. C. are shortly to leave for Cincinnati. They will carry with them the best wishes of their fellow citizens of the city of Austin - and should they ever wish to return to the mountain city, they will meet with a hearty welcome from its inhabitants.

Saturday, Oct. 17, 1840 p. 2, col. 3 (con't.)

Major Samuel Whiting, publisher of the City Gazette, left this place sometime since. We have heard by a letter from Houston that he is circulating a report in the lower country that the Sentinel is shortly to be discontinued. We envy not the prosperity of the man who would seek to advance his own interest by an act of such consummate meanness.

\$60. reward - for Joseph Perkins and Benjamin Decker, deserters from Austin Arsenal. Description - Joseph Perkins, 28 years old, 5 feet 6 inches high, fair complexion, light hair and eyes, by profession an engineer, and was enlisted last May by Capt. J. Weihl at Galveston. He carried away a rifle, and wore a blue cap, blue pantaloons, and grey fatigue jacket.

Benjamin Decker, 40 years old, 5 feet 9 1/2 inches high, fair complexion, dark eyes, black hair, by occupation a carpenter, and was enlisted last May by Capt. J. Weihl at Galveston.

The above reward will be given for both, or thirty dollars for each deserter.

Abstract of Confederate Pension Application #28689

(The original pension applications are on file at the Texas State Archives. All Confederate pension applications did not call for identical information. This is being submitted as an example of what information one might expect to find on a Texas Confederate, or Confederate's widow's, application.)

Mrs. Mary Wheeler - Travis Co., Texas - P. O.: Austin, R.F.D. #5, Box 91 filed June 1914; pension allowed from Sept. 1, 1914

I, Mrs. Mary Wheeler, ... am the widow of S. H. Wheeler, deceased, who departed this life on the ___ day of Dec. 1892 in the county of Travis, in the state of Texas. ... I was married to him ... in Travis Co., Texas ... shortly after the close of the War. ... I am 81 years old ... born in Mississippi ... have resided in Texas about 60 years at my present address. ... husband did not draw a pension ... his full name was Solomon H. Wheeler ... his command was organized in Texas. He enlisted Oct. 24, 1862 in Travis Co., & served to the close of the War. He was in Company "C," 33rd Texas Cavalry.

Affidavits by witnesses: Frank M. Glasscock and H. M. Metz who state that Solomon H. Wheeler served as above stated under Capt. John H. Robinson and Col. Duff; that affiants served in the same company with applicant's husband and knew him well - before, during, and after the said War. (signed) 11 August 1914

Application for Mortuary Warrant: by Lee Patton, who was the person entrusted with paying the accounts and indebtedness of the late Mrs. Mary Wheeler who died 24 February 1920 in the town of Oak Hill, Travis Co., Texas. The pensioner died at the home of her son, Tom Wheeler. ... I am her son-in-law. My home is in the town of Oak Hill, Travis Co., Texas.

Certificate of Undertaker: V. O. Weed states that he prepared the body for burial and burial was in the Oak Hill Cemetery.

Whatsoever our said attorney shall lawfully do in the premises we do hereby confirm the same as if we were personally present and did the same in our proper persons.
