- 1. Mr. & Mrs. Julian Lewllyn, Conroe, Texas, written on back. Photo taken by C. R. Blackburn Studio, Houston, (Harris Co.) Texas imprinted on the front of the cabinet card.
- 2. Sarah Ann Llwellyn, age 16 mo., written on the back. Photo taken by Miller Studio, Marlin (Falls Co.) Texas imprinted on the folder.
- 3. "Shazzie" age 4 1/2 mo., is written on the front of this cabinet card photo. On the back side it says "Mrs. Lewellyn". Photo taken by Wilcox Studio, Georgetown, (Williamson Co.) Texas printed on the front of the card.
- 4. Mary Frances Llewellyn, age 3 yrs. Photo taken by Gray Studio, 502 1/2 Main St., Houston (Harris Co.) Texas.

- 7. Edwin Hailey: boy about 4 yrs old in knickers, no location on photo. "To Uncle Henry & Aunt Beckie" written on card.
 - 8. Mrs. J. S. Gasendus (spelling is unclear) on 85th birthday, no location.
- 9. Hildagard Marshal: photo taken by Chicago Gallery, San Diego, San Diego Co. California.
- 10. Kurtiz Weston & Bess Bull, no location. The first name is not really clear. These are two young women all dressed up. I am hoping somebody can connect them to the Lewellyn family. No location on this photo.

The Land Before Her: Fantasy and Experience of the American Frontiers, 1630-1860, by Annette Kolodny

Printed by the University of North Carolina Press, Chapel Hill, 1984, paperback with pioneer log cabin picture front and spine, with family and team of horses. Prologue and Epilogue included in 241 pages; also 39 pages of (foot) Notes, nine pages of Bibliography, 10 pages of Index of names and places. Book borrowed from family member. Hailed by Harvard reviewer on back cover as in "forefront of feminist literature."

This book explores a large variety of printed and unprinted manuscripts, journals, newspaper articles of the time, and then-popular books purporting to be descriptions of women's pioneer life; also some women's help in writing enticement literature for land developers.

The author interprets the early ads and writings designed to attract new settlers as being very "erotic" in touting "virgin forests" to be conquered by the "new Adam" in a "new paradise," and even says that the state name "Virginia" was based on that concept. (I always thought it was for the "Virgin Queen!") "Eve" then was to create the "Garden of this new paradise, bringing the seeds from her former home, for flowers and vines and vegetables. (No snake was mentioned to tempt her, but she did bring knowledge in the form of starting schools, churches and the arts.)

Some of the earlier writings are of the "captivity" genre, about women and children captured by Indians; some of them actually preferred to remain with their captors, especially if they had become wives and had children, saying that their peers would look down on them, and they loved the families they had produced; or that they preferred the simpler lives of the Indians to the confusion of the cities.

The thick forests of the settlements in the earlier frontiers were a frightening thing to many women, who felt closed in, with no open places to even consider planting sun-loving flowers for their "Eden." Only in the later Midwest of Ohio and beyond did they see the land as a "park" with open spaces dotted by clumps of trees; the many wild flowers of the prairies was a continuing theme in the popular books written for women of the time. Sadness at the anticipated spoiling of the land by cities and industry started to appear in works written by women.

There are many references to Daniel Boone and his prototypes as the adventuring hunters; also conflicting ideas of Indians as the "noble savages" versus the "blood-thirsty killers" and thieves.

The latter part of the book devolves into a critique of the popular literature of the later pioneering period, much apparently written for pioneer or would-be pioneer women, but by women who had never been, or only briefly, in the wilderness settings, somewhat glamorizing the experience or showing the result of a generation or two of the hard work of settlement, with larger two-story houses having replaced the cramped, essentially windowless log cabins in which women worked, hardly able to go outside with the many indoor chores and childcare, then still hardly seeing the sun for the heavy forestation.

In spite of the excessive repetition, an interesting book, especially the quotations from actual women's journals and manuscripts of the time.

Austin Street Names: Then and Now

Reprinted from AGS Quarterly, September 1985

The north/south streets of Austin between East Avenue, now IH35, and West Avenue were named for rivers in Texas beginning on the east with Sabine and ending on the west with Rio Grande. The east/west streets were named for trees. In the late 1880s the tree-named streets were changed to numbered streets.

Ash Street became 9th Street Bois d'Arc became 7th Street Cedar became 4th Street Cherry became 16th street Chestnut became 18th street College Avenue became 12th Street Cypress became 3rd Street Elm became 20th Street. Hickory became 8th Street Laurel became 26th Street. City Public Free School

From Frank Brown's "Annals of Travis County and the City of Austin," Vol. 35

Frank Brown is an ancestor of Austin Genealogical Society member Anne Darden Gilbert of Union, Washington. He is buried in the family plot at Oakwood Cemetery. The 36 volumes of the "Annals of Travis County and the City of Austin" can be found on the shelves of the Austin History Center and the Center for American History.

In the early part of 1881 Col. A. P. Wooldridge called upon the leading men of Austin and urged upon them the need of Austin assuming control of the public free schools within its corporate limits and organizing and developing them along the best modern lines. He stated that Austin would probably gain the location of the entire University of Texas, or the main branch of it, and a systematic, well considered and sustained effort should be undertaken to make the city free schools equal to any and the city, itself, and educational center. A mass meeting was held, at the county courthouse at which it was determined to adopt the policy he advocated.

The meeting nominated some of the best men in the city to constitute the first board of trustees, regardless of politics; some were Democrats and some were Republicans, but all gentlemen of high standing. At the special election subsequently held to determine the public will, substantial majorities were secured in favor of changing from the old community to the independent district system, for vesting the control of the schools in a board of trustee and not in the city council, and for levying a special tax of 25 cents on the \$100 property valuation for the support of the schools. The trustees proposed were elected by large majorities.

The first board of trustees consisted of the following gentlemen: A. P. Wooldridge, President; R. C. Ludlow, Wm. Von Rosenberg, Sr., J. B. Rector, R. F. Campbell and H. S. Still. Col Von Rosenberg resigned and Dr. R. M. Swearingen was elected in his stead at the time the special tax was voted County Judge Z. T. Fulmore and Mayor W. A. Saylor were ex-officio members.

At a later election the tax rate was raised to 33 1/3 cents on the \$100. That it has not been increased since is a circumstance worthy of remark.

The city public free schools began their first session, under the new regime, Monday, September 12, 1881, with a total attendance of 500 pupils, and with John B. Winn (elected by the board) as first Superintendent of city schools.

The Daily Statesman of Tuesday, September 13, 1881, contains a signed statement of Prof. Winn giving the attendance, the various schoolhouses in use and names of teachers. The high school and principal subordinate school for whites occupied what is now the Pease school building, on Rio Grande street in west Austin. A gentleman connected with the schools at that time says that this building was the only one owned by the city, and that the others (mostly wooden structures) were rented. The schools, both white and colored, grew rapidly, and it required energetic and resourceful action upon the part of the board to provide additional school room and equipment. The latter at first consisting of very little that was of any value.

The manual training department of the high school was established in September 1896, and owes its origin and support to a fund created by the last will and testament of John T. Allan, who died at his home in Austin Sunday January 22, 1888, and was buried the following day, Rev. E. B. Wright, of the first Presbyterian church, conducting the religious services.

Allan was born in Edinburgh, Scotland and was about 62 at the time of his death.

Mr. Allan's will was as follows: "Know all men by these presents that I, John T. Allan, of Austin, in the county of Travis and state of Texas, being of sound mind, though in feeble health, considering the uncertainty of life, do hereby make and publish this as my last will and testament and repealing all or any former will or testament by me made.

"First, I give and bequeath to Geraldine C. Osborne, daughter of Daniel C. Osborne, of New Orleans, La., five thousand dollars.

"Second, I give all the rest of my property, real and personal and mixed, to the city of Austin, in Travis county, state of Texas, in trust for the following purposes, to wit: To establish in the city of Austin aforesaid an industrial school, in which shall be taught the practical use of tools, as well as scientific principles as applied to labor.

"Third, I hereby appoint James P. Richardson and L. N. Goldbeck both of Austin aforesaid, to be executors of this my last will, 18 Jan. 1888."

The will was probated April 7, 1888. The inventory they returned showed the estate to be worth \$43,604.33. Under order of the court, entered at the April term, 1889, the executors turned over all of the property to the board of school trustees of the city of Austin, the board by resolution April 10, 1889, accepting the trust. The estate was converted into cash, which was loaned at interest (the interest being compounded from year to year) until the manual training department of the high school was opened.

The fund has subsequent to the year 1900 been invested in storehouses and other city property that command good rentals. It is understood that the Allan fund (under this excellent management) now amounts to about \$60,000, which yields ample revenue for the support of the manual training department. The equipment of the department (not included in the foregoing estimate of the fund) is said to be about \$10,000.

I have given this much space to the account of the origin and statue of the Allan fund, for the reason that, so far as I know, it made the city of Austin the pioneer municipality introducing industrial education into the public free school in Texas.

The present commodious and imposing high school building, located on the northeast side of Ninth street, between Trinity and Neches streets, was completed at a cost of \$45,000 and occupied in the year 1900. The following gentlemen were members of the board: J. B. Rogers, R. M. Castleman, J. W. Graham, Jefferson Johnson, Dr. W. J. Matthews, Dr. Geo. P. Garrison, Dr. M. M. Smith, and Superintendent of Schools T. G. Harris.

For a number of years the Temporary Capitol was the home of the high school, \$2,000 per year rent being paid. After the burning of the Temporary Capitol in September 30, 1899, the high school was domiciled in the Smith office building on West Sixth street, until the high school building as erected and occupied.

John B. Winn served as Superintendent of city schools until failing health compelled him to resign the position in 1894. He was then succeeded in 1895 by T. G. Harris, who served until after the year 1900.

Judge Fulmore served on the board of trustees a great many years, and was a tower of strength to it amidst the perplexities and struggles it encountered in building up what is confessedly one of the best systems of city public free schools in the state, and in conserving and applying to best advantage the Allan fund. One of the city schools is named Wooldridge School and another Fulmore School as recognition of the services of those gentlemen.

A park in the city has also been named for Col. Wooldrigde.

It would also be difficult to overestimate the value of the services of Graham, Tips, Litten, Matthews, and other trustee, a record of whose services are preserved in the minutes of the board.

From 1881 to 1884 inclusive, the scholastic age was from 8 to 14 years; 1885 to 1893, from 8 to 16 years, 1894 to 1900 and later from 8 to 17 years.

The scholastic census for the year 1900 showed that there were in the city 4,256 children within the scholastic age. The total enrollment for the year 1899-1900 was 3,632 (2,675 white, 957 colored), total attendance 2,743, percentage of attendance 94.24,

The following statistics relating to the Austin public schools for the year beginning Sept. 1, 1900, are taken from the report of the State Superintendent of Public Instruction:

Total white and colored 3,205 within school age.

White children over school age, white male 20, female 58, total 78;

Colored children over school age, colored female 7,

Total white and colored 85 over school age.

White children under school age, white male 141, white female 174, total 315;

Colored children under school age, colored male 18, female 25, total 43;

Total white and colored 358 under school age.

Grand total enrollment, white male 1,292, female 1,434, total 2,726;

Grand total enrollment, colored male, 429, female 493, total 822,

Grand total white and colored 3,648.

School houses owned, white 6, (wood 1, stone 4, brick one), colored 4 (wood);

leased rented or used without rent, white 1 wood, 1 brick, total school houses 12.

Estimated value of school houses and grounds owned \$174.100; total value of property \$190,550.

Amount received from county apportionment \$2,794.80; from local school taxes \$41,106.61 from tuition from pupils over and under age, \$860.60; from all other sources \$925.02, total from all sources, \$65.903.03

About Frank Brown

Frank Brown, author of "Annals of Travis County and the City of Austin,: was born on June 26, 1833, in Nashville, Tennessee. The Brown family came to Texas in 1835. He married Georgiana McLemore in Austin on Jan. 1, 1856.

Brown was elected county clerk of Travis County, probably in 1856, and was reelected in 1858 and 1862. In 1865 he was appointed clerk of the district court and city alderman of Austin. From July 1865 until January 1867 he was associated with James A. Foster as publishers of the Austin "Southern Intelligence." Brown was commissioned clerk of the district court in 1866 and later elected to the post. He resigned in 1869, was reappointed and resigned again the same year. He was clerk of the district court in 1873 and of the county court in 1876 and was reelected for each term through 1892.

After Brown's retirement he compiled his "Annals of Travis County and the City of Austin." His manuscript is a storehouse of information about the history of the Austin area in the second half of the nineteenth century. He died at Austin at the home of his daughter, Mrs. Henry Hutchings, on Jan. 27, 1913.

History of Stephen F. Austin High School Seven campuses, one school, "Loyal Forever"

We feel that Austin High is the "oldest, continuing, tax-supported, locally controlled, public high school in Texas." That doesn't make us "better" necessarily, but it surely does make us "different."

First Day, First Campus: First day of school was Sept. 14, 1881, held in two classrooms on the third floor of building at 11th and 12th on Rio Grande – West Austin High School, later Pease Elementary. Thirty-three girls and 18 boys attended. First graduates in 1883.

1884: We ran out of space at Pease School and moved to four Sunday school rooms at First Baptist Church, then located across the street from the Governor's Mansion at 10th and Colorado. We were using the entire Sunday school space by the time we left 10 years later. Campus Number Two.

1894: The school district leased the temporary Capitol Building of Texas at 11th and Congress. The first and third floors were rented out, and the second floor was used as the third AHS campus with first eight, 11 and 15 classrooms by 1899. The schools and the state argued over who should put in electrical wiring. The city got a light plant in 1892, but the old building still used gas lamps for light. Whoever did the wiring did it cheaply, because one recurring story is that the Sept. 30, 1899, fire was started by a squirrel shorting out the wires up in the attic. The building burned to the ground.

1899: For six weeks there was no school, until mid-November. Then the school district rented a second story room in the 100 block of West Sixth Street, the Smith Opera House. Wires were strung along the ceiling and curtains hung to divide the 40-feet wide by 130-feet long room (with stage at one end) into 12 classrooms. Campus Number Four.

1900: The Sixth Street lease was used for the rest of the 1900 school year. By September 1900 the "finest high school in the South," under construction at the time of the fire, was ready. The red brick building at 9th and Trinity had 18 classrooms. We used the building until 1925, and additions of rooms were made, which just about filled the block. It was called "Old Red" because of the red bricks. Campus Number Five. The building was John Allan Junior High, 1925-1956. In 1956 another fire that "lit up the night sky for 20 miles" burned the building down.

1925: As the Thanksgiving holidays began, teachers and kids packed their books and lunchboxes and went home. The next Monday, the old junior high was moved to the 9th and Trinity location (Old Red) and the high school kids went to 12th and Rio Grande, where a junior high school had been built in 1915. This became the sixth AHS campus. The 1920 Memorial of Peace was moved in 1926 from 9th and Trinity to 12th and Rio Grande. Many modern school organizations trace their beginnings to the Rio Grande campus, used until 1925 as Austin High.

1953: Three new high schools opened, and we were officially renamed Stephen F. Austin High School. Everyone still calls us "Austin High" or "Austin of Austin." The building was air conditioned in 1967, but as the '70s began, it was clear that a replacement for the Rio Grande building would have to be provided. Many mementos of the 50 years at the Rio Grande campus were packed for the move to the Lakeside campus. A special focus was the moving of the 1920 Memorial Stone to a location at the east entrance at the lakeside campus.

1975: Lakeside campus opened at 1715 West First Street, renamed Cesar Chavez Street in 1993. The land had been part of the 330 acres donated to the city as parkland – Zilker Park – by A. J. Zilker in 1927. First day of school was Aug. 24, 1975.

2006: The 125th anniversary of Austin High School. To commemorate this event in Austin High's history, a "Super-Reunion" is being organized for the weekend of Oct. 20-21 to bring together alumni, parents and friends to celebrate.

I have intended many times when we have been together to put the simple question, which this note is intended to propose; but although it seems the easiest thing in the world to make an offer of marriage, yet when the heart is as deeply interested in the answer as mine is, it is apt to fail one at the critical moment. Can I, dare I hope, that you will permit me to call you mine? Am I mistaken, misled by vanity, in supposing that this proposal, made in the truest spirit of respectful love, will not be displeasing to you? My position and prospects warrant me in saying that I can provide for you a comfortable home, and I may truly add that without you no place can be a home to me.

Anxiously awaiting your answer, I remain, Yours affectionately,

Favorable reply

Dear Sir!

Your offer of marriage is certainly unexpected, but it is made in a manner so diffident and respectful as to preclude the possibility of its giving offence. I am not offended, but marriage is a serious matter and although I confess my own inclinations are in your favor, I must advise with those who have a right to be consulted, before I give you a decided answer. I think I may say however, in the mean time, that you need not despair.

Unfavorable reply

Dear Sir!

You have addressed me in plain and earnest language, and I feel it my duty to give a candid and positive answer to your proposal, without delay. I cannot accept your offer. As an acquaintance I have found society agreeable, but have never thought of you as a lover. It is therefore utterly impossible that I can respond favorable to your letter. Thanking you for the honor you have done me, but at the same time requesting you to consider this offer finally declined.


Uncle Carl ("Carl Thomas Bair) was a tall man for his generation, probably 6' or 6'l", athletic build, sandy red hair, and ruddy complexion; always jolly, and had a big grin, but very smart and sophisticated in spite of country boy appearance. He and Aunt Carol were successful enough to travel a lot in their older years, and spent many winter months in Hot Springs, Arkansas, which seemed to help his arthitis. He was quite crippled in his legs the last few years, and used cruthes, then a wheel chair at last. Aunt Carol must have had osteoporosis and was bent over increasingly from about 55 years of age.

My most pleasant memories of Uncle Carl were when my grand-father, William "Henry" Bair, took us to visit the farm at Union, Iowa. My two brothers and I always tagged along that first day, when Uncle Carl took Grandpa for an "inspection" of the farm, the buildings, animals, and the fields. When we came to the creek, with willow trees, Uncle Carl always cut a branch, and hollowed out all but the very upper part. The center of the branch was very soft and rather "cottony", and easy to push out. He then cut little finger holes, and we were delighted to each have our pipes to play, given to us, hand-made by Uncle Carl.

One year, I spent a delightful summer week with them at the farm, gathering eggs with Aunt Carol, watching them milk, and going with them in the truck to pick up the milk from the renters on their neighboring farm. I loved to play with their cats and kittens, and play in the very low-bent branches of the huge evergreen trees at the front of the yard. One appeding kitten was my favorite, and I talked to it, calling it "Sweetheart" one day. They told me later, that became it's name. I still have the pictures they took of me in that big low branch, holding "Sweetheart". For that week, at least, I think I became the child that they never had, and they sent me a doll that Christmas, which, of course, I named "Carol", for her and for the season, both.

This sketch was written in conjunction with an attempt to confirm the family "myth" [?] that Uncle Carl had been in the Cavalry, U.S. Army, WW I. He rode a motorcycle delivering messages in France; I have a picture of him in uniform seated on a horse.

Carl Bair was born Sept. 18, 1890, near Ladora. He was the son of Mr. and Mrs. W. H. Bair of Mt. Vernon. The family moved to Mt. Vernon in 1912. Carl Bair attended Cornell from 1911 - 1913 and subsequently farmed northeast of Mt. Vernon. He married Carol Cromer, whom he had met at: Cornell.

The couple moved to near Union, Iowa, in 1919, where they became successful farmers. Mrs. Carl Bair survives her husband and lives at the Mayflower home in Grinell.

Carl Thomas Bair was born Sept. 18, 1890 on a farm 10 miles south of Victor. He was the son of Mr. and Mrs. W. H. Bair who later moved $1\frac{1}{2}$ miles west of Ladora.

A graduate of Ladora High School, he attended Cornell College. While in Ladora he was in the National Guard and lived in Mt. Vernon in 1912-1913. During World War I he was in camp in Towa and in France, receiving an honorable discharge.

Returning to farm on the W. H. Bair Farm near Ladora, he was married to Carol Cromer in July of 1920 and farmed from 1920-1929, later moving to a farm at Union.

They entered the Mayflower Rest Home in Grinell in 1975 where they had an apartment. He died in the care center Nov. 15 and was buried near Union.

He is survived by his wife, Carol; one brother, Volnie Bair of Rochester, Wisc.; and one sister, Mae Bair Starry of Dunnellon, Fla.; two brothers, Roy Bair, Victor, and Russell Bair, Mt. Vernon, preceded him in death. Mr. Bair was a first cousin of Spencer Maudlin and Mrs. Blanche Peterson, both of Victor.

Jumping the Tracks

Today is Sunday, March 26, 2006. It is a typically beautiful Texas spring day; a good breeze out of the southeast, intense blue sky, some puffy cumulus clouds dot the sky, temp in the low 70s. "Life is good," I think as I walk home from church. And as I walk, I remember that I will have to cross the Union Pacific railroad tracks, formerly the Missouri Pacific tracks.

There is a flashback to times long ago, as many of us are prone to do. I had the thought, "this is a story that I want to save and share with family and friends." I mentally composed and organized as I walked.

Here is a 65-year backward journey to my grandparent's East Texas town of Diboll. It probably was Easter, based on the Sunday clothes and the weather, which was much like today's as we now approach Easter. It was one of the three annual pilgrimages back to Diboll by the Agee descendants. The other two events were Thanksgiving and Christmas. Over the years I can recall three sons and two daughters, three spouses and seven grandchildren, 17 in all. They were happy, festive gathering as the family shared stories of present and past. The Sunday dinner, a noon meal, was a feast with multiple dishes of fresh vegetables, sweet potatoes, ham gravy, several salads, home made hot rolls, desserts and a huge ham which had been rubbed with brown sugar and pierced with clove buttons to be carved at the table while mouths watered.

On Saturday afternoon there were Easter egg hunts in the piney woods not far from the house, conducted by some of the ladies of the Methodist church. The grandkids had their baskets and eagerly darted about looking for the colored eggs or running to where another child had just found an egg. One year the hunt was rained out so our hunt was on the large screen porch.

The First Methodist Church of Diboll was where the Agee family attended. It was a wooden building, painted white with some arched windows, eight or ten wooden steps up to the vestibule, immediately under the modest bell tower, wooden pews, choir chairs on the left of the platform and on the left of the sanctuary was an alcove behind folding doors with additional chairs for overflow crowds. There was a black sign with white movable letters hanging to the right of the platform showing attendance, offering and hymn numbers. The church was on a point where a side dirt street intersected what was probably the old dirt road that ran through Diboll on the way to Lufkin but now that road was the main street and was kept oiled to hold down the dust.


Parallel to this main street were the Southern Pacific railroad tracks running from Houston to Lufkin, to Shreveport and beyond. There were four sets of track, two sidings and two north and south main lines. Grandad's and Granalee's house was almost exactly across from the church but on the other side of the tracks. Come Easter Sunday morning, everyone was dressed in their finery, my girl cousins in their new lacy, pastel-colored dresses, the ladies in their bright dresses with hats, gloves and heels, the men in suits and ties. The Agee family was ready to go to church.

Mom's sister, Julia or Aunt Dooley to the children, was a happy, outgoing and outspoken woman. As we gathered on the long screen porch that ran across the front of the large two story house, ready to go the church less than 50 yards away, the inevitable question came up, "How are we going, in the cars or walk?" Aunt Dooley, always one to be a leader, spoke up, "Come on Mary Jane. You're young. Let's go jump the tracks like we did when we were kids." So we all headed out to "jump the tracks" to get to church. Bob, one of Granalee's sons drove her three houses down their street to the railroad crossing and around to the church, arriving at the same time as the "track jumpers."

A Street Named McCurdy


We were pleased and excited to read the morning paper on September 1, 2004 announcing the names of new streets which will be located on the old Mueller Airport property. We learned that McCurdy Street was named after my father-in-law, John Anderson McCurdy. The 44 new streets were named after various Austinites for various reasons, including civic leaders, musicians, actors, and individuals who had contributed to aviation in Austin. John McCurdy was in the aviation category, along with folks like Cal Rodgers who landed the first airplane in Austin October 20th, 1911, Robert Mueller who had been instrumental in establishing our first real airport, and Claire Chennault who was the WWII leader of the famed Flying Tigers. John's contribution to aviation in WWI was leading the cross country flyers from Kelly Field in San Antonio to Penn Field in Austin in early 1918.

After the US entered WWI in April 1917 a universal draft was initiated. John registered June 5, 1917 in San Antonio, indicating that he was an "Electrical Mechanic". He enlisted July 18th and then applied for training as a pilot in the relatively new Air Service of the Army Signal Corps. Marian and I have speculated as to why he set his sights on flying airplanes, but then started thinking: He had been living in San Antonio for a little over a year -fresh from the romance of homesteading in New Mexico for a couple of years. He had experienced many new challenges and accomplishments there and most likely looked at the new aviation era as romantic and challenging. He probably saw planes flying in his part of town because Stinson field had been established there as a flying school in 1916. Land in San Antonio had been obtained for Kelly Field and in the Spring of 1917 it was designated as one of the flying fields of the country. It is not surprising then that he applied for pilot training.


During the summer of 1917 numerous hangers, shops, buildings and barracks were erected and the Flying Department became a reality at Kelly. John took basic training, including engine repair and navigation at the University of Texas School of Military Aeronautics in Austin on the University of Texas campus; then later in abandoned buildings at 19th and East Avenue.(now UT's Little Campus) Then he joined the 16th Flight Training Class of October 27, 1917 at Kelly. The training plane used was a Curtis JN-4, known as the "Jenny"and was the most popular training plane used by the Allies. (I was

fortunate to see a restored "Jenny" at the Boeing Flight Museum in 1999) According to John's Pilot's Book, he took his first flight on November 19th and soloed on December 8th.

One of the civilian instructors at Kelly was Eddie Stinson, a well known aviation pioneer. His sister, Katherine, had become the fourth licensed female pilot in the US and toured the country as a stunt pilot, becoming one of the country's most famous female aviators. The family, mother Emma, sisters Marjorie and Katherine, and brothers Eddie and Jack established the Stinson Aviation Company in Hot Springs, Arkansas, but moved it to San Antonio in 1913 where the army granted permission to use the parade ground at Ft Sam Houston as a landing field. Marjorie and Eddie ran the flying school on the drill field from 1914 to 1915. In 1916 the family leased 500 acres of farmland from the city and established Stinson Field from where John probably saw the planes flying. Once Kelly Field came into operation, the Stinson family trained the U.S. and Canadian pilots. John said Eddie Stinson was a great pilot and instructor – but he had a drinking problem and the students apparently had to sober him up on a regular basis.

By the first of January 1918 John became an instructor for Cross County Flights. His job was to line up landing fields within a hundred mile radius of Kelly Field. The previous year the Austin Chamber of Commerce had secured 318 acres of land just south of St Edwards University which could be developed into a landing field. John contacted the Chamber and made a flight to Austin and landed on the 318 acre tract. His wind gauge was a handkerchief held by a man on the ground. He was pleased with the field except for its rocky condition and some remaining corn stalks and began bringing in formation flights of 12 to 20 planes several times a week. There were a few minor accidents from the flint rocks causing blown tires and fabric tears so the Chamber of Commerce organized over six hundred men and boys to come out on Four Sundays to pick up and haul away 317 truck loads of the offending rocks. 1 The

field was named after Eugene Penn, a soldier from Austin killed in a flight training exercise in

Italy.

John made many flights to and from Penn Field and told his family some of his stories. If any of his pilots went down for any reason, he generally would have to find them and hopefully get them back in the air. Pilots were not given parachutes and were expected to land their planes if they experienced any trouble. "The airplanes were too expensive to abandon by bailing out" they were told. One afternoon he had landed to help one of his students get back in the air and by the time he started back to San Antonio, it was getting dark. With no lights and none of the instruments later available for flying at night, he basically used his compass to get back to Kelly. There were no landing field lights at Kelly and the only light was a flood light atop one of the hangers. John started buzzing the field in hopes of someone shining the light on the field so that he could see where to land. To his dismay the person behind the light kept shining the light on the plane and in his eyes. He kept buzzing the field to indicate he needed the light to help him land and finally the light shiner caught on and lit the ground so that he could land. He had made the first night landing at Kelly Field.

He continued to be in charge of Advanced Cross Country flying until March 21, 1918 when he and nine other officers from Kelly were ordered to Lonoke, Arkansas to open up Eberts, a new flying field. He was in charge of flight operations with orders to keep the planes in the air throughout the daylight hours. During his stay here, the influenza pandemic broke out and most of the men went down with it. The camp doctor, an alcoholic, panicked, locked up his medicines, and went A.W.O.L. The cabinets had to be broken open to get the medicines needed to treat the afflicted patients.

On December 20, 1918, thirty nine days after the Armistice, he received his honorable discharge.

After the war, he had tempting opportunities to keep on flying as a test pilot; but his realization that his father was not well and he might be called on to take on increasing family responsibilities sent him back to school. He wanted to be a medical doctor; but time was pressing, and he studied business administration and received his B.B.A. degree from the University in 1922. After graduation, he went to Sweetwater, a small town in West Texas, as secretary of the Board of City Development. In 1924, he married May Lea Guthrie and in1926 they returned to The University of Texas at Austin where he served as Executive Secretary of the Ex-Students Association until retirement in 1956.

This past December Marian and I went to a Christmas Play at Penn Field. It was interesting to walk around all the buildings and development of the area and realize that some 88 years ago, her dad was landing and taking off from these grounds in a primitive old airplane called a "Jenny."

Thank you Austin, for honoring him with the naming of a street.

Hurricane Katrina: Disaster's impact on archives

Now that we are several months into the recovery process resulting from the Katrina Hurricane, the value of our personal records and archives becomes very evident.

As our new neighbors are looking for records to help them retain and re-establish their precious identity that has been so suddenly ripped away, we all become painfully aware of just how meaningful these records are to all of us. The family photographs, the birth certificates, the death certificates, the social security cards, the proof of academic achievement, the records of successful passage of the bar exam and many other certifications are needed in order to establish a new role in a new community.

So many people left their homes without insurance policies in hand, and for those whose family photographs were drowned or left to be overtaken by mold and are now forever gone, for those whose mortgage records were stored in basements and the first floors of our government buildings, for those whose medical records could not be saved, for those who business records flew out broken windows, and for countless other reasons, these survivors are painfully aware of the value of archives and records.

These documents for some also provide tangible evidence of one's very existence and provide an invaluable sense of self-worth, of identity. Many are unique and many are irreplaceable. Nothing can substitute for the preservation of these records and the archives. They are unique, and they are priceless. They contain information of continuing value for the survivors and for the continuity and story of our great and very diverse nation.

For those who are curious about the survival of the archives in New Orleans, I can offer this information reported in "Government Records News," the newsletter of the government records section of the Society of American Archivists.

"The New Orleans City Archives reopened to the public on November 29 after being closed for three months following Hurricane Katrina. Archivists Wayne Everard and Irene Wainwright will provide access to the collection on Tuesdays and Thursdays from 11 a.m. - 3 p.m. They are among the nineteen New Orleans Public Library staff members who survived the massive layoff of city workers in mid-October. That layoff was necessitated by the fact that the city's tax base was effectively wiped out by the Katrina disaster. It is unclear at this time when NOPL and the City Archives will be able to return to anything approaching pre-storm operating levels.

"The City Archives is part of NOPL's Louisiana Division, housed in the Main Library in downtown New Orleans. The collection comprises municipal records (1769-date) along with civil (1804-1926) and criminal (1830-1931) court records from Orleans Parish. Katrina spared the records despite the fact that most of them are stored in the building's sub-basement some eighteen feet below sea level. Just about every other building in the vicinity did flood, but the Library somehow managed to stay dry. Several record series housed off site, though, were damaged when the roof of the warehouse facility blew away in the storm. The damaged materials were recovered by Munters and should be back in New Orleans by the time these words are published.

"In addition to the City Archives, the Louisiana Division also houses the NOPL Special Collections. Included under that umbrella are the Louisiana Photograph Collection (1860s-2002), the Louisiana Map Collection (1763-1997), the Carnival Collection (1860s-2004), the

Manuscript Collection (1801-2000) and a number of collections of ephemera. None of the Special Collections were damaged by Katrina, nor were any of the general materials in the Division (books, periodicals, microforms, city and state documents, vertical files and the NOPL genealogy collection).

"Although NOPL's Main Library was spared, eight of the system's thirteen facilities suffered severe flood damage and will be closed indefinitely. Only Main and two of NOPL's smaller branches are currently operating – they are providing only limited services during shortened hours. The New Orleans City Archives, the New Orleans Public Library and the entire City of New Orleans are on a long, slow, difficult path to recovery. We need the help of our government and the help of our friends. For more information on the New Orleans Public Library and the City Archives and their recovery, please visit the Library's web site at http://nutrias.org."

Rand Jimerson, former President of the Society of American Archivists recently reminded us that "our democratic institutions depend on accurate records and public access to such information." This statement holds great meaning, particularly to our new neighbors from New Orleans now living in Austin. In order to assist archives and archivists with whom our affinity is so great, the Society of Southwest Archivists and the Society of American Archivists announced the creation of the SSA-SAA Emergency Disaster Assistance Grant Fund, a fund established to address the stabilization and recovery needs of archival repositories damaged by Hurricanes Katrina and Rita. Any repository that holds archival records or special collections and that is located in those hurricanes' affected areas of Alabama, Florida, Louisiana or Mississippi is eligible to apply for a grant.

Grant money may be used for the direct recovery of damaged or at-risk archival materials; such services as freeze-drying, storage, transportation of materials and rental facilities; supplies, including acid-free boxes and folders, storage cartons, cleaning materials, plastic milk crates and protective gear; and to defray the costs for volunteers or other laborers who assist with the recovery. A review panel of four SSA former presidents and the immediate past treasurer, along with one member of the SAA Council, will review applications and select the grant recipients. The committee will score proposals based on the application criteria. The Society of American Archivists is responsible for financial administration of the fund. Brenda Gunn, Assistant Director for Research and Collections at The Center for American History, Austin, Texas, is current president for the Society of Southwest Archivists is the person to whom grant applications from archives can be submitted.

This is a unique opportunity to assist our neighbors, and one that reminds us of how vulnerable our archival collections are and how important archives and records are to each one of us.

Index to naturalization records to 1906 in Travis County, Texas

Recorded by Kay Dunlap Boyd, Austin

This index began in the November 2002 issue, which ran names Juan Aballos through Alfred Boles. In 2003, the March issue ran names Carl O. Bollman through Phillipp Doppenschitt, June's names ran from Ramon Dorado to Hugo Erzkus, September's from Faustina Escobar to Marcallino Gamez and November's from H.P.M. Gammel to Gustav Hebbe. The March 2004 issue names were from Otto Hebbe to Frederick Hutz and no names ran in the June 2004 Quarterly. September 2004 featured the naturalization records of Carl Hyltin to August Josefson and December 2004 names were C.A. Josefsson to P.J. Lewgren. In March 2005 names ran from Tom Lewis to Herman Nelson, June 2005 from J.A. Nelson to George Pflueger and in September/December 2005 names ran from Bernhard Pfoffman to Hermann Schoen.

Between 4,000 and 5,000 names are on this complete index, which was entered from a microfilm copy of the WPA Index at the Austin Public Library's Austin History Center. The microfilm is available at Austin History Center and through LDS Family History Centers. Complete recorded paper copies are on file at Austin History Center and at Texas State Library Genealogy Collection. The entire file has been entered electronically and is being loaded in parts at the Austin Genealogical Society Web site, www.AustinTxGenSoc.org.

The microfilm record contains this statement:

"Complete Index to Naturalization Records of Travis County, prepared by the State Wide Records Project of the WPA, sponsored by the Department of Justice through the Naturalization and Immigration division of the Federal Government. It took several months to compile this record by a staff of workers under the direction of Mr. E.C. Duke, District Supervisor (without cost to Travis County). This is a complete record of naturalization proceedings in the Probate, County and District Court of Travis County; at the time the County was organized, either of the three courts handled naturalization matters. Since 1906, all such matters have been handled by the U.S. District Courts. The preparation of this record was in line with a general program over the entire Country, and the copy of the record was given the District Clerk's Office for the cooperation it gave the Staff that worked here on the project.

"Requests for information in regard to Naturalization Records have been numerous recently, due to Social Security Laws, Old Age Assistance Benefits and war conditions requiring the establishment of citizenship."

It is natural for a mother to have a good opinion of her child, and to speak well of him; but when I assure you that my son is a worthy young man, who is esteemed by all his acquaintances, it is but the simple truth. An alliance with a lady of your character and education has always been my most anxious wish for him.

The Austin Genealogical Society General Information

PURPOSE Austin Genealogical Society was organized in 1960 as a not-for-profit corporation chartered by the State of Texas. Its purposes are to collect and preserve genealogical and historical information about the people of Texas, particularly pertaining to the City of Austin and to Travis and surrounding counties, to instruct and assist members in genealogical research, and to publish public and private records of genealogical interest. In addition, the AGS supports the Texas State Library's Genealogical Collection and Austin Public Library's Austin History Center by donations of books and other genealogical material. Gifts and bequests to AGS are tax-deductible to the full extent permitted by law.

MEMBERSHIP is open to all upon payment of annual dues. Classes: Individual: \$20; Family (two in the same household): \$30; Patron of AGS: \$100; Lifetime: \$500 (\$300 if over age 65). All classes entitle one copy of each issue of the Quarterly and the monthly Newsletter, as well as two pages apiece (a total of four pages for Family or higher whether one or two people submit listings) in the Ancestor Listing issue, the June Quarterly. After July 1, dues are \$10 for the balance of the year, but you will receive only the publications produced after the date you join. Membership includes a copy the annual Membership Handbook, which is published each spring.

Dues for Existing Members are payable on or before January 1 of each year for the ensuing year. If dues are not received by February 1, the name must be dropped from the mailing list. If membership is reinstated later and Quarterlies and Newsletters have to be mailed individually, postage must be charged. (Back Quarterly issues are supplied only if available). Carefully check horizontal pages (reading in the 11-inch direction) so that one-inch margins are on top, bottom and both sides so no information is lost in stapling. No 8½ x14 sheets, please. You may submit lineage or family group charts, ahnentafels, narratives, memoirs, letters, cemetery inscriptions, Bible records, census data, queries or a combination of material, just so it is not under copyright. Proofread your material for accuracy and clarity so we will not publish faulty or incorrect data. Consult a recent June AGS Quarterly for suggestions.

Remember, individual membership secures two facing pages, and family or higher membership allows you four pages.
